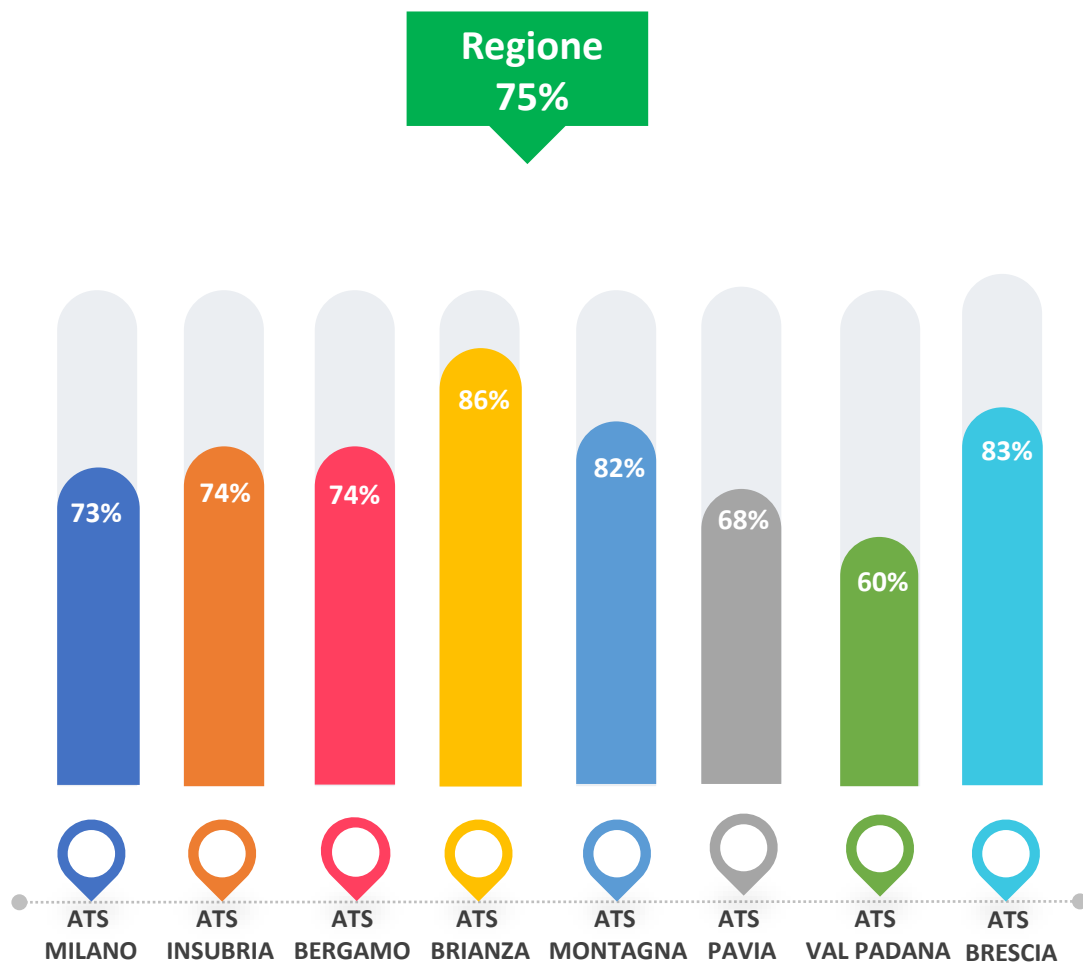

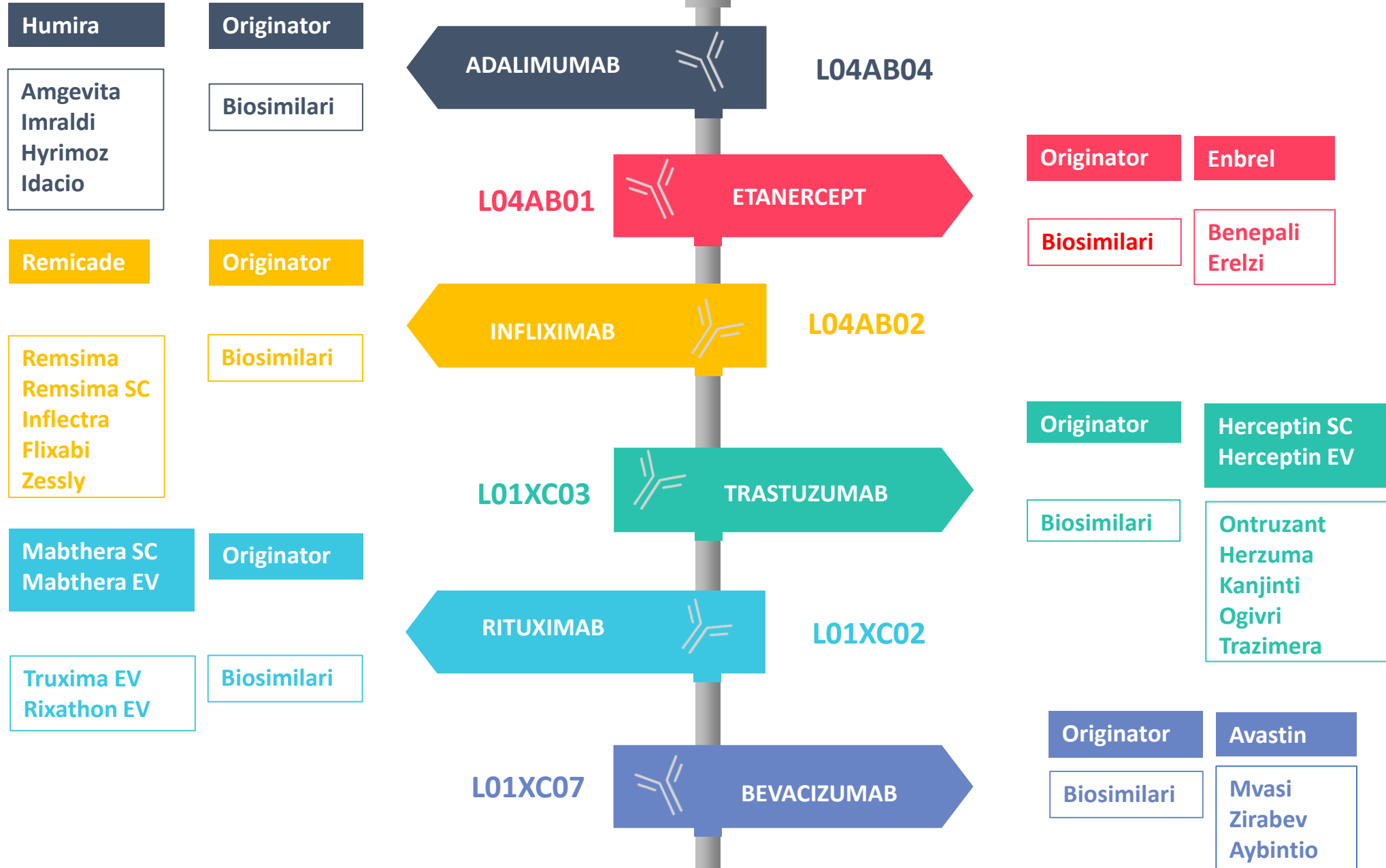


Metodologia

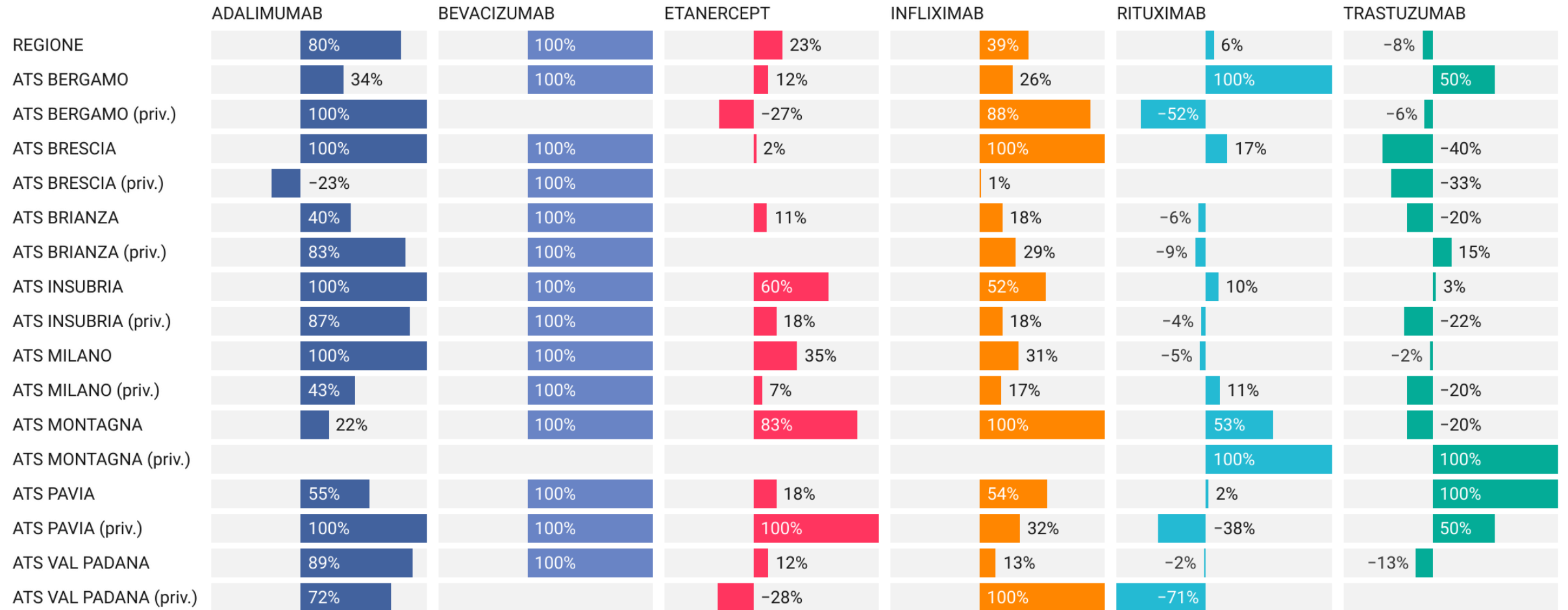
